



**Ocean Park Corporation
Tai Shue Wan – Water World
Natural Terrain Hazard Mitigation Works
Invitation to Contractors to Submit an Expression of Interest**

Ocean Park Corporation (the Corporation) invites Expressions of Interest from Contractors who are interested in tendering for Natural Terrain Hazard Mitigation Works of the Tai Shue Wan Water World Development (the “Project”) of Ocean Park.

The Corporation intends to engage a contractor to carry out the Natural Terrain Hazard Mitigation works for the Project. In outline, the scope of the works will comprise general site clearance, design, supply and installation of flexible barrier, gabion wall, in-situ stabilization of unstable rock outcrop or boulders (with rock dowels, concrete buttresses, rock mesh, etc.), soil slope stabilization with soil nail, shotcrete and erosion control mat, and miscellaneous minor concrete elements. The works are currently anticipated to be carried out between December 2017 and November 2018.

Expressions of Interest should contain, as a minimum, the following information:

1. Brief details of Natural Terrain Hazard Mitigation works undertaken in the past 3 years including nature of works, type and number of flexible barrier, contract duration and value.
2. Safety record, with details, of Natural Terrain Hazard Mitigation contracts undertaken in the past 3 years.
3. Details of any Labour Department (or other authority) prosecutions in the past 3 years.
4. Details of ‘Notices of Dispute’, if any, issued by the Contractor within the past 3 years.
5. Overall management and resources, including knowledge, experience, capability and availability of key staff.
6. Copy of current Registration Certificates as a Registered General Building Contractor and Registered Specialist Contractor (Site Formation Works and Foundation Works Categories) issued by the Buildings Department.
7. Last 3 Years’ audited financial statements.

All of the above points must be addressed in the Expressions of Interest, which should not exceed 15 sheets of single sided A4 text (with no further attachment) with a minimum font size of 11 points and must be deposited in our **tender box situated at the Administration Building Annex of Ocean Park, Aberdeen, Hong Kong**, at or before **3:30pm on 25 August 2017**. Submissions by fax or email will not be accepted. Items 1 to 5 will be assessed on a weighted basis in the submission evaluation, whilst items 6 and 7 will be evaluated as either Pass or Fail.

Six hard copies and two soft copies of the Expressions of Interest must be contained in a sealed envelope marked with the following details:

The Corporation intends inviting shortlisted entities in due course to submit tender proposals. Applicants who do not hear from the Corporation within three months should consider their Expressions of Interest unsuccessful.

The Corporation is not bound to shortlist any entities who have submitted an Expression of Interest, and reserves absolute discretion not to invite any entities (whether or not it has submitted Expression of Interest) to submit any tender proposals.
